## - Results of the November 6, 2012 Election - County Board of DD Levy Issues, Across the State

Results for issues on November 6 ballots affecting Ohio's developmental disabilities community:  
(Percentages are rounded.)

<i>Carroll County:</i> 1 mill, renewal	PASSED, by 57%
<i>Clark County:</i> 1.75 mills, additional	FAILED by 51%
<i>Defiance County:</i> 0.85 mills, renewal	PASSED, by 68%
<i>Fayette County:</i> 1.5 mills, replacement	PASSED, by 67%
<i>Medina County:</i> 1.9 mills, replacement	PASSED, by 63%
<i>Meigs County:</i> 2 mills, renewal	PASSED, by 61%
<i>Morrow County:</i> 1.5 mills, replacement	FAILED by 56%
<i>Paulding County:</i> 1.4 mills, renewal	PASSED, by 63%
<i>Sandusky County:</i> 2 mills, additional	PASSED, by 56%
<i>Trumbull County:</i> 1.5 mills, renewal	PASSED, by 67%
<i>Tuscarawas County:</i> 1.7 mills, renewal	PASSED, by 71%
