- Results of the November 8 Election - County Board Levy Issues, Across the State



Results of the voting on issues in the November 8 election affecting Ohio's developmental disabilities community:

- *Adams County*: .8 mills, renewal – PASSED, 54%
- *Ashland County*: 2.1 mills, renewal – PASSED, 74%
- *Ashtabula County*: .5 mills, renewal – PASSED, 63%
- *Darke County*: 2 mills, renewal – PASSED, 68%
- *Franklin County*: 3.5 mills, replacement – PASSED, 67%
- *Mahoning County*: 2 mills, renewal -- PASSED, 72%
- *Morgan County*: 1.97 mills, renewal – PASSED, 59%
AND 1.28 mills renewal – PASSED, 58%
- *Morrow County*: 1 mill, additional – FAILED, 39%
AND 1.25 mills, additional – FAILED, 33%
- *Scioto County*: 1 mill, renewal – PASSED, 67%
- *Summit County*: 4.5 mills, renewal – PASSED, 70%
- *Union County*: 3.8 mills, renewal – PASSED, 61%
- *Wyandot County*: 2.95 mills, renewal – PASSED, 70%

Results are unofficial and will be certified by respective County Boards of Elections at a later date.
