

Overtime Rates- 2020 Update

Overtime rates are available to eligible independent providers who work more than 40 hours in a work week under a waiver program or as a private duty nurse through the Ohio Departments of Medicaid (ODM), of Aging (ODA), and of Developmental Disabilities (DODD).

January 2020

For service dates beginning January 1, 2020, the Medicaid maximum payment rates are increasing for Homemaker/Personal Care (HPC), Participant-Directed Homemaker/Personal Care (PD-HPC), and On-Site/On-Call (OSOC). The new maximum payment rates for those services when the provider has worked over 40 hours in a week are below.
