

## State Resources / Contracts Available for Use by County Boards

The Department of Administrative Services (DAS) Office of Procurement Services has several contracts available for health, medical, and personal protective clothing and supplies. County Boards of Developmental Disabilities (DD) are eligible to utilize these contracts as part of the Community Rehabilitation Program (ORC 125.60 through 125.6012) and Cooperative Purchasing Program (ORC 125.04). The Department of Mental Health and Addiction Services (DMHAS), Ohio Pharmacy Service Center, is also a resource for supplies as noted below (ORC 5119.44).

These are optional resources that allow the County Boards to benefit to purchase goods from state contracts awarded by the Department of Administrative Services (DAS) and receive the same pricing negotiated for state agencies under these contracts. If a County Board would like to purchase goods from one of these contracts, the County Board will contact the supplier listed directly and letting the supplier know they are wanting to place the order in accordance with the DAS contract and refer to the specific contract number. The County Board is responsible for contacting the supplier directly to place the order and pay for the receipt of the goods ordered under the contract.
